

## BYLAW NO. 4320, 2012

A Bylaw to provide for a bylaw enforcement ticket system

WHEREAS:

- A. Section 264 of the *Community Charter*, S.B.C. 2003, c. 26, as amended (the “*Charter*”) authorizes the City of Coquitlam (the “*City*”) to enact a bylaw to provide for the issuance to tickets to enforce its bylaws;
- B. Council for the City has previously enacted the *City of Coquitlam Bylaw Enforcement Ticket System Bylaw No. 3713, 2005*, and wishes to replace it with this bylaw;

NOW THEREFORE, the Council of the City of Coquitlam, in open meeting lawfully assembled, ENACTS AS FOLLOWS:

### 1. Name of Bylaw

This Bylaw may be cited for all purposes as the “*Municipal Ticket Information Bylaw No. 4320, 2012*”.

### 2. Bylaws to be Enforced

The bylaws listed in Column 1 of Schedule “A” to this Bylaw may be enforced by means of a ticket in the form prescribed for the purpose of section 264 of the *Charter*.

### 3. Bylaw Enforcement Officers Appointed

The persons acting in the job positions or titles, and any successor positions or titles, listed in Column 2 of Schedule “A” to this Bylaw are designated as bylaw enforcement officers for the purpose of enforcing the bylaws referred to in the corresponding Column 1 of Schedule “A” of this Bylaw.

### 4. Words or Expressions to Designate Offences

The words or expressions shown in Column 1 of Schedule “B” to this Bylaw designate the offence committed under the bylaw section number appearing opposite such words or expressions in Column 2.

**5. Establishment of Penalties**

The amounts shown in Column 3 of Schedule “B” to this Bylaw are the penalties established for the offence shown opposite the amount in Column 1 and, in the case of a continuing offence, the amount shown in Column 3 will be for each day that the offence continues.

**6. Schedules**

Schedules “A” and “B” attached to this Bylaw are an integral part of this Bylaw.

**7. Severability**

If any portion of this Bylaw is held invalid by a Court of competent jurisdiction, then the invalid portion must be severed and the remainder of this Bylaw is deemed to have been adopted without the severed portion.

**8. Repeal**

*City of Coquitlam Enforcement Ticket System Bylaw No. 3713, 2005* is hereby repealed in its entirety.
