### A Bylaw respecting the enforcement of bylaw notices

WHEREAS the Local Government Bylaw Notice Enforcement Act, S.B.C. 2003, c. 60, as amended (the “Act”), provides that a local government may deal with the contravention of a bylaw by bylaw notice.

NOW THEREFORE, the Council of the City of Coquitlam, in open meeting lawfully assembled, ENACTS AS FOLLOWS:

#### 1. Name of Bylaw

This Bylaw may be cited for all purposes as the “Bylaw Notice Enforcement Bylaw No. 3749, 2006.”

#### 2. Definitions

- (a) In this Bylaw, unless the context otherwise requires, each of the following words has the meaning set out below:
  - (i) “City” means the City of Coquitlam;
  - (ii) “Registry” means the Coquitlam Bylaw Notice Adjudication Registry established under section 6 of this Bylaw.
- (b) Other terms used in this Bylaw have the same meaning as defined terms in the Act.

### **3. Bylaw Contraventions**

The bylaw contraventions designated in Schedule “A” may be dealt with by bylaw notice.

### **4. Penalties**

The penalty for a contravention referred to in section 3 is as follows:

- (a) subject to paragraphs (b) and (c), is the Penalty set out in column 4 of Schedule “A”;
- (b) if received by the City within 14 days of the person receiving or being presumed to have received the bylaw notice, is the Discounted Penalty set out in column 3 of Schedule “A”; or
- (c) if paid under a compliance agreement, may be reduced as provided under column 5 of Schedule “A”.

### **5. Period for Paying a Disputed Notice**

- (a) A person who receives a bylaw notice must, within 14 days of the date on which the person received or is presumed to have received the bylaw notice:
  - (i) pay the penalty, or
  - (ii) dispute the bylaw notice by completing an online ticket dispute form, located on the City of Coquitlam website.
- (b) A person may pay the indicated penalty more than 14 days after receiving the bylaw notice, in accordance with section 4(a), but no person may dispute the bylaw notice more than 14 days after receiving the bylaw notice.
- (c) Pursuant to the requirements of section 25 of the Act, where a person was not served personally with a bylaw notice and advises the City that they did not receive a copy of the original bylaw notice, the time limit for responding to a bylaw notice under section 5(b) of this Bylaw does not begin to run until a copy of the bylaw notice is re-delivered to that person in accordance with the Act.

### **6. Bylaw Notice Dispute Adjudication Registry**

- (a) The Registry is established as a bylaw notice dispute adjudication system in accordance with the Act to resolve disputes in relation to bylaw notices.
- (b) The civic address of the Registry is 500 Mariner Way, Coquitlam, B.C., V3K 7B6.

- (c) Every person who is unsuccessful in a dispute adjudication in relation to a bylaw notice or a compliance agreement under the dispute adjudication system established under this section must pay the City an additional fee of \$25 for the purpose of the City recovering the costs of the adjudication system.

## **7. Screening Officers**

- (a) The position of screening officer is established.
- (b) The title of the person acting in the capacity of screening officer will be “Compliance Officer”.
- (c) The persons holding these positions are hereby designated and appointed as screening officers:
  - (i) General Manager Community Safety;
  - (ii) Senior Manager Bylaw Services;
  - (iii) Manager Bylaw Enforcement Operations;
  - (iv) Manager Administrative Services and Animal Shelter;
  - (v) Bylaw, Licensing and Animal Services Supervisor;
  - (vi) Customer Service Supervisor;
  - (vii) Bylaw Inspector 2;
  - (viii) Bylaw Inspector 1;
  - (ix) Bylaw Inspector 3;
  - (x) Bylaw Clerk;
  - (xi) Licence Examiner;
  - (xii) Parking Patrol Officer
  - (xiii) any successor positions or titles to those listed in this subsection.

## **8. Powers and Duties of Screening Officer**

- (a) The powers and duties of screening officers are as set out in the Act, and include the following:
  - (i) the screening officer must, upon receipt of a request for dispute adjudication from a person against whom a contravention is alleged, advise the person of the bylaw notice adjudication system established by this Bylaw, including, without limitation, advise the person of the action which the screening officer may take pursuant to this section 8 with respect to the bylaw notice and of the opportunity to proceed to dispute adjudication of the bylaw notice;
  - (ii) where requested by the person against whom a contravention is alleged, communicate information respecting the nature of the contravention, the provision of the bylaw contravened, the facts on which the contravention

allegation is based, the penalty for a contravention and the fee or fees payable in relation to the bylaw notice enforcement process;

- (iii) communicate with any or all of the following for the purposes of performing their functions under this bylaw or the Act:
    - 1) the person against whom a contravention is alleged or their representative;
    - 2) the officer issuing the Notice;
    - 3) the complainant or their representative;
    - 4) the City's staff regarding the disputant's history of bylaw compliance;
  - (iv) review the City's records regarding the disputant's history of bylaw compliance;
  - (v) prepare and enter into compliance agreements under the Act with persons who dispute bylaw notices, including establishing terms and conditions for compliance that the screening officer considers necessary or advisable, including time periods for payment of penalties and compliance with the bylaw;
  - (vi) provide for payment of a reduced penalty if a compliance agreement is entered into, as provided in column 5 of Schedule "A"; and
  - (vii) cancel bylaw notices in accordance with the Act and City policies and guidelines.
- (b) The bylaw contraventions in relation to which a screening officer may enter into compliance agreements are designated in column 5 of Schedule "A".
  - (c) The maximum term of a compliance agreement is one year.

## 9. Bylaw Enforcement Officers

Persons acting as any of the following are designated as bylaw enforcement officers for the purposes of this Bylaw and the Act:

- (a) Members of the Royal Canadian Mounted Police;
- (b) Bylaw Enforcement Officers appointed pursuant to the Police Act and the Community Charter;

- (c) Local Assistants to the Fire Commissioner under section 6 of the Fire Services Act;
- (d) The persons acting in the following job positions or titles, and any successor positions or titles:
  - (i) General Manager Community Safety; Senior Manager Bylaw Services; Manager Bylaw Enforcement Operations; Manager Administrative Services and Animal Shelter; Bylaw, Licensing and Animal Services Supervisor; Customer Service Supervisor; Bylaw Inspector 2; Bylaw Inspector 1; Parking Patrol Officer; Bylaw Inspector 3; Bylaw Clerk; Licence Examiner;
  - (ii) Fire Chief; Deputy Fire Chief; Assistant Fire Chief; Chief Fire Prevention Officer; Training Chief; Fire Captain; Fire Inspection Captain; Lieutenant – Fire Prevention; Fire Inspector;
  - (iii) General Manager Engineering and Public Works; Senior Manager Design and Construction; Manager Capital Projects and Inspections; Director Transportation; Traffic Operations Engineer; Director Public Works; Sewer and Drainage Superintendent; Water Superintendent; Roads Superintendent; Senior Manager Environment; Environmental Education and Enforcement Manager; Environmental Services Project Specialist; Environmental Services Coordinator; Water Conservation Program Coordinator; Solid Waste Programs Specialist; Environmental Stewardship Coordinator; Environmental Services and Worksite Bylaw Officer 1 and 2; Urban Wildlife Program Coordinator; Water Conservation/Urban Wildlife Bylaw Officer; Engineering Assistant; Environmental Protection Officer; Director Utilities; Environmental Compliance Specialist;
  - (iv) General Manager Planning and Development; Director Development Services; Director Building Permits; Director Urban Planning and Design; Manager Development Planning; Development Project Facilitator; Manager, Building Permits—Approvals; Manager, Building Permits—Inspections; Manager Plans Examination; Trades Inspection Supervisor—Building; Trades Inspection Supervisor—Plumbing; Building Inspectors 1 and 2; Plumbing Inspectors 1 and 2; Manager Development Servicing Engineering, Development Servicing Supervisor; Supervisor Planning Services; Planners 1, 2 and 3; Planning Technicians 1, 2 and 3; Planning Assistant 2; Construction Site Liaison; Front Counter Supervisor; Customer Service Supervisor;
  - (v) General Manager Parks, Recreation Culture and Facilities; Senior Manager Parks; Park Operations Manager; Manager Landscape; Manager Parks Infrastructure; Manager Parks Services; Manager Cultural Services; Manager Community Recreation; Manager Urban Forestry and Park Services; Urban Forestry Services Supervisor; Urban Forestry Technician; Forest Management Technician; Manager

Sports Services; Manager Parks Planning and Design; Parks Resource Technician;  
Natural Areas Supervisor; Cemetery Supervisor;

**10. Form of Bylaw Notice**

The City may from time to time provide for the form or forms of the bylaw notice, provided that the bylaw notice complies with section 4 of the Act.
